INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the STATE PC AB16-09 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. The flowline was previously abandoned on 5/1/2010, prior to the registration rules. Therefore, the line is unregistered and there is no corresponding ECMC Form 44 Document number.

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample was collected at the wellhead excavation, and soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

No impacted soils were discovered during wellhead cut and cap activities. Based on site investigation activities and laboratory analytical results of confirmation soil samples collected from the wellhead excavation floor, and wellhead flowline riser, removal of soil is not needed. The material excavated during the cut and cap operations was used as backfill for the excavations.

OPERATOR COMMENT

Facility closure activities and confirmation soil sampling were conducted at the State PC AB16-09 Wellhead on June 03, 2024. Four discrete soil samples were collected from the sidewalls of the wellhead excavation in each cardinal direction from the wellhead and field screened using a photo-ionization detector (PID) calibrated with 100 parts per million (ppm) isobutylene gas. All soil samples screened with a PID at the wellhead resulted in readings less than or equal to 1.0 ppm.

A total of 2 facility closure confirmation soil samples were submitted for analysis. Soil Samples were collected from the floor of the wellhead excavation (WH01 @6), and from beneath the flowline riser adjacent to the wellhead (FLR01 @4). All soil samples were submitted to Origins Laboratory, Inc. in Denver, Colorado for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, gasoline range organics (GRO) [C6-C10] by EPA Method 8260D, diesel range organics (DRO) [C10-C28] and residual range organics (ORO) [C28-C40] by EPA Method 8015D, polycyclic aromatic hydrocarbons (PAHs) (Table 915-1 list) and naphthalene by EPA Method 8270E, Total Metals by EPA Method 6020B, Hexavalent Chromium by Total Metals by 7196A Method, electrical conductivity (EC) by Mod. Method 9050A, sodium adsorption ratio (SAR) by 20B Saturated Paste Method, and pH by 9045D Method, and boron by DTPA Sorbitol Method.

All analytical results for soil samples submitted for analysis are compliant with their respective Table 915-1 Protection of Groundwater Soil Screening Levels (GWSSLs), except for arsenic in soil samples WH01 @6 (4.58 mg/kg) and FLR01 @4 (4.39 mg/kg), barium in soil sample FLR01 @4 (88.8 mg/kg), and pH in soil samples WH01 @6 (8.43) and FLR01 @4 (8.40). All organics were reported as below their respective laboratory method detection limits. Groundwater was not encountered during wellhead cut and cap activities.

Noble is currently in the process of evaluating residual arsenic, barium, and pH concentrations at the wellhead. Flowline was abandoned on 05/10/2010, prior to registration rules and is therefore unregistered with no corresponding ECOM Form 44 Document number.
