On Wednesday, 09/11/2024, Inspector Kirby Burchett, conducted a routine field inspection at Argali Exploration Company on the Simpson 24-10 well, Location #313289, in Moffat County, Colorado.

This location is within or close proximity to a Parks & Wildlife (CPW) District with High Priority, NSO, Density and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

While there during normal operations the following compliance issues were observed:

1. Debris
2. Unused equipment.
3. Equipment open to wildlife.
4. Open ended tank valve.
5. Tank missing required information.
6. No sign at tank battery.
7. No sign at wellhead.
8. Relief risers missing caps.

9. Review of production records indicate operator is delinquent in submitting monthly operations reports.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with ECMC rules.
