**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the WOLFE USX CC07-25 wellhead cut and cap and will be conducted to the flowline abandonment. The wellhead was cut and capped per ECMC rules. Approximately 1483' of flowline was abandoned-in-place due to field constraints. The ECMC will be updated on a supplemental Form 27 if the flowline is to be removed at a later date. The Form 44 Document number will be provided on a supplemental Form 27.

**PROPOSED SAMPLING PLAN**

**Proposed Soil Sampling**

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

Four (4) grab soil samples were collected at the wellhead excavation (1), flowline connection to the wellhead (2), and flowline connection to the separator (1).

Soil samples will be collected along the flowline path at any points of directional change.

Soil samples were/will be analyzed by a certified laboratory for the full extent of Table 915-1, including: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were/will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

A site investigation will be scheduled to assess the flowline directional change, with samples collected for full ECMC Table 915-1 analysis. Additional backgrounds (5+) will be collected from soil of native/similar lithologic material not impacted by oil and gas activity to further compare EC, SAR, pH, boron, and ECMC Table 915-1 metals, as needed.
