A site investigation will be conducted pursuant to ECMC Rule 911 at the DILLARD T7N-R64W-S10 L06 Facility and Tank Battery location.

Grab confirmation soil samples will be collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), at the risers for the flowline (s) and dumpline(s) of any separator(s). In addition, the on-site dump lines located between the separator and tank battery will be removed by pulling from either end. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6 -C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Visual inspection at the tank battery area will occur during abandonment activities. Field personnel will field screen all disturbed areas using visual and olfactory senses. Additionally, discrete soil samples will be collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. The ECMC Tank Battery and Produced Water Vessel Closure Checklists will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

See the following comments:</p> <p>Form Denied: Noble has resubmitted form with plans for a tank battery decommissioning, but ECMC records in COGIS indicate tank battery was likely decommissioned prior to 2021:</p> <p>The Dillard AB 10-07 well was drilled and completed in 2010. A tank battery remained onsite according to COGCC inspections through April 2019.</p> <p>9/3/2019 - 10/25/2019: A Form 27 was submitted in September 2019 for the removal of the buried produced water vessels at the location. See Remediation Project #14127, Form 27 Document #s 402163530 and 402220885.</p> <p>5/18/2021: A COGCC Field Inspection Report (Document #696104571) indicates no tank battery equipment was on the location and the well was in Temporarily Abandoned status due to the inability to produce the well.</p> <p>4/8/2024: Noble submits an Initial Form 27 (Document # 403746369) for assessment of the Dillard AB 10-07 well and cut & cap. Attached aerial imagery shows now production facilities on the location. ECMC approved Form 27 on 6/11/2024 and assigned Remediation Project 35730.</p> <p>7/18/2024:Noble submitted an Initial Form 27 (Document #403859308) describing a tank battery abandonment but provided a figure for assessment of a well. ECMC returned this Form 27 to Draft on 9/9/2024. Noble resubmitted this Form 27 on 9/9/2024 with a map showing assessment of a tank battery, but COGIS records and aerial imagery would indicate that tank battery does not exist.</p> <p>If Noble has remaining production facility or tank battery assets on this location to abandon, Noble shall submit a new site-specific Initial Form 27 Site Investigation and Remediation Workplan to describe exactly what assets are present and how they will be investigated.</p>	09/13/2024
