INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the VOLKENS 02 flowline removal. Approximately 805' of flowline was removed. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The wellhead was previously cut and capped per ECMC rules.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A (1) grab confirmation soil samples was collected along at the wellhead excavation in the area showing the highest degree of impact during field screening activities during the wellhead excavation. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

The flowline was previously decommissioned and submitted in a previous Form 27 (doc# 403629133).

Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The wellhead was previously cut and capped per ECMC rules.

A grab confirmation soil sample was collected at the point of wellhead excavation. In the absence of any elevated hydrocarbons, and with consideration to all other soil suitability parameters in compliance with ECMC Table 915-1, the elevated pH value at the wellhead appears to be consistent with background comparison and does not appear indicative of an E&P release. Based upon the depth and level of soil suitability impacts, the risk to vegetation is likely negligible. Based upon this and the use of inspections to monitor future growth, no additional assessment or remediation appears necessary. The previous flowline assessment also so no impacted soil, and as a result we are requesting NFA designation.
