Operator Comment: Please see the attached documents. This location has been FAN'd by the BLM in 2019. There is language in the FAN regarding the access road stating the road existed prior to the well pad and will remain in place.

Utah Gas Corp has ordered weed spraying at this location; since it occurred late in the season, UGC plans to monitor this site in the spring.
