A third party hauling company had an oil spill of 2.5 bbls outside of containment. The impacts were limited entirely on pad and a hydrovac was immediately dispatched to begin the cleanup. Due to the spill being strictly crude oil, Bonanza requests an amended SAP to include TPH (C6-C36) and Organics only. The impacted soil will be removed and hauled for disposal.
