INITIAL ACTION SUMMARY

Description of initial action or emergency response measures taken to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the STROH H12-03 wellhead cut and cap and flowline removal. Approximately 1951' of flowline was removed, along with the previously abandoned-in-place flowline, STROH H12-04, that is in the common trench with STROH H12-03. The wellhead will be cut and capped per ECMC rules. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. A grab confirmation soil sample was collected at the wellhead excavation. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

A proposed SSI map is attached to this Form 27. Based on the ECMC Table 915-1 exceedance identified during decommissioning, Noble proposes to limit future soil sampling to pH. Concurrently with the SSI, additional background samples will be collected to determine if pH is attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

The implementation schedule has been changed due to the decommissioning of the STROH H12-03 wellhead and flowline and necessity for supplemental site investigation activities adjacent to the wellhead and flowline. The proposed site investigation will be completed following the approval of this form, landowner negotiations, and crew availability.

OPERATOR COMMENT

This Form 27 is being submitted as a Third Quarter 2024 timeline update for the completion of a SSI at the Stroh H12-03 wellhead and flowline location. The SSI will be completed in accordance with the Site Investigation Report section of this Form 27, and the attached proposed soil boring map.

Based on the contaminants of concern identified during decommissioning, Noble proposes to limit future soil sampling to pH. Concurrent with delineation activities, additional background samples will be collected to determine if pH observed at this location are indicative of native material conditions.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The ECMC will be updated with the results of the supplemental site investigation on a subsequent Form 27.
