1. Abstract: survey, Northern Pump Co.'s Government #3-1 well site; 660 X 860' area surveyed - no cultural resources found. Archeological clearance for project recommended.
- 2.a. Resource Area: White River Planning Unit:
Location: T1N R102W Sec. 3 USGS Quad: Rangley
3. Project Description: well pad Size: 325 X 275
well pad and alternate location: alternate located 175' south of preferred location

Topography: bench on south side of White River; nearly flat terrain

Vegetation: saltbush, cheat grass, bunch grasses, sagebrush, prickly pear, and a few scattered juniper
4. Examination Procedure: series of transects spaced 15m apart walked across area 660 X 660' surrounding both well locations, inventoring a 660 X 860' area (13 acres)
5. Findings: no cultural resources found; improved road to east to be used for access - has been previously surveyed and currently being used for access to oil field; much of the survey area has been severely disturbed (powerlines, roads, wells)
6. Recommendations: archeological clearance for the project is recommended
all access is either in the 660 X 860' surveyed area or is on the previously surveyed and improved road to east of pad

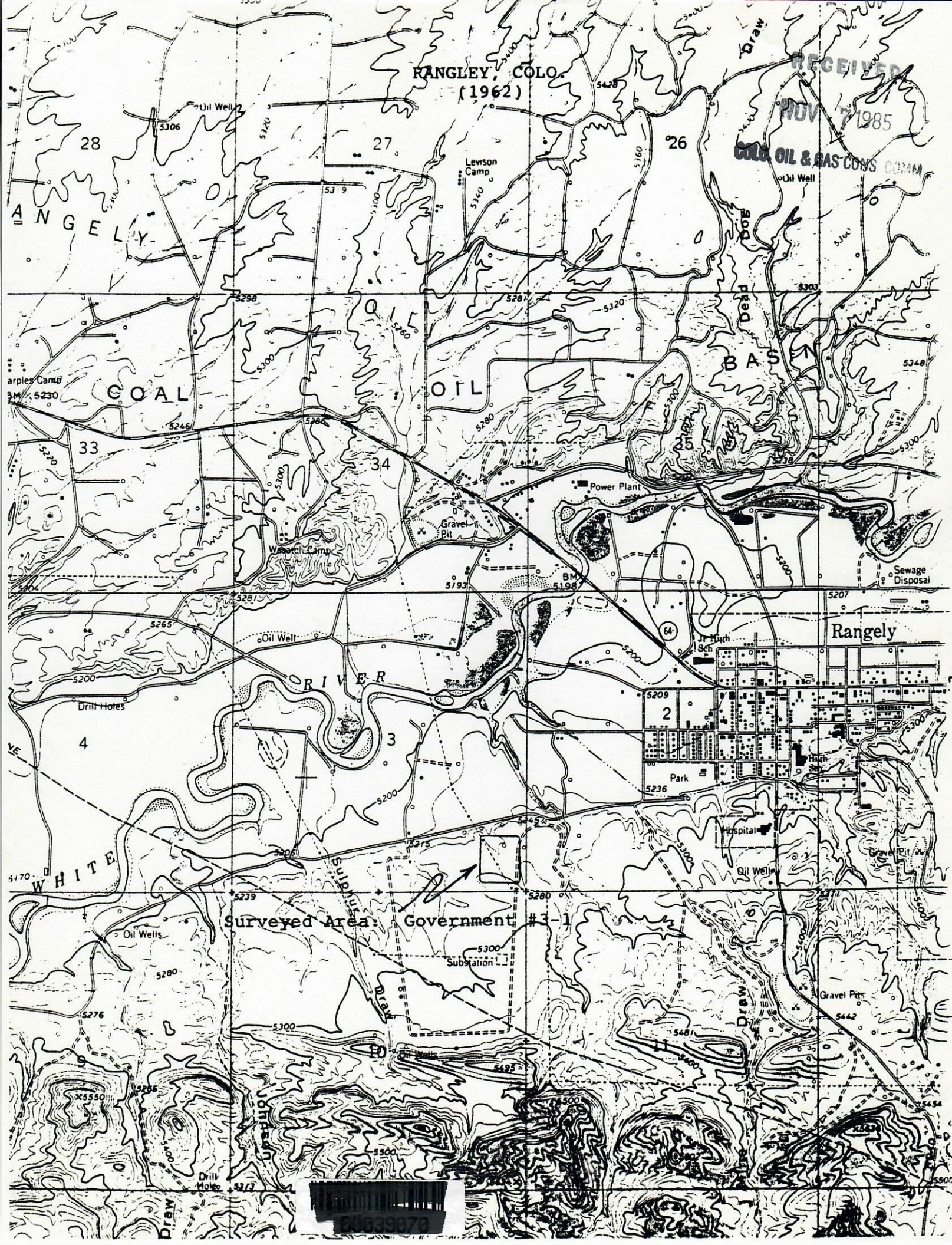

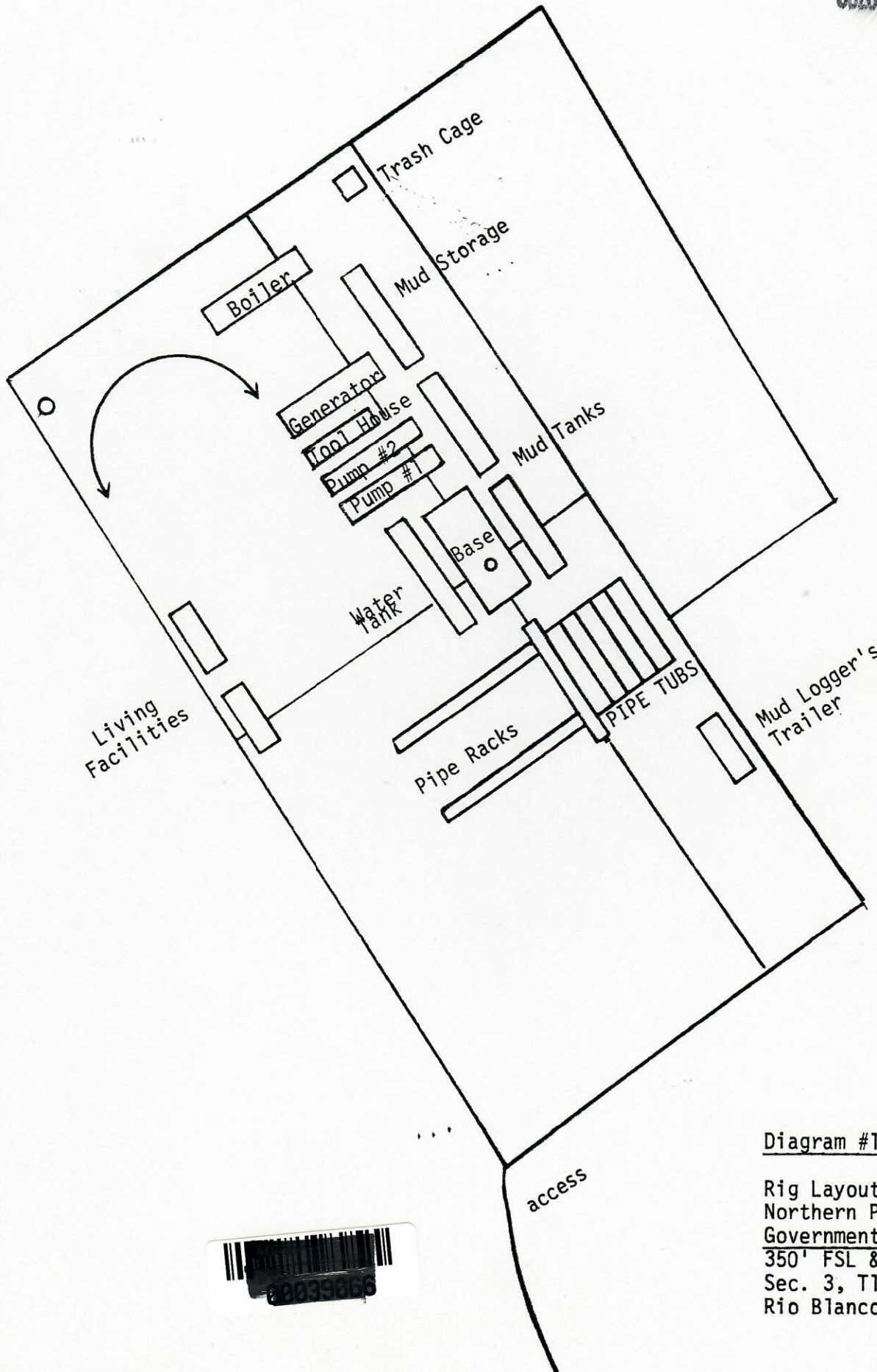

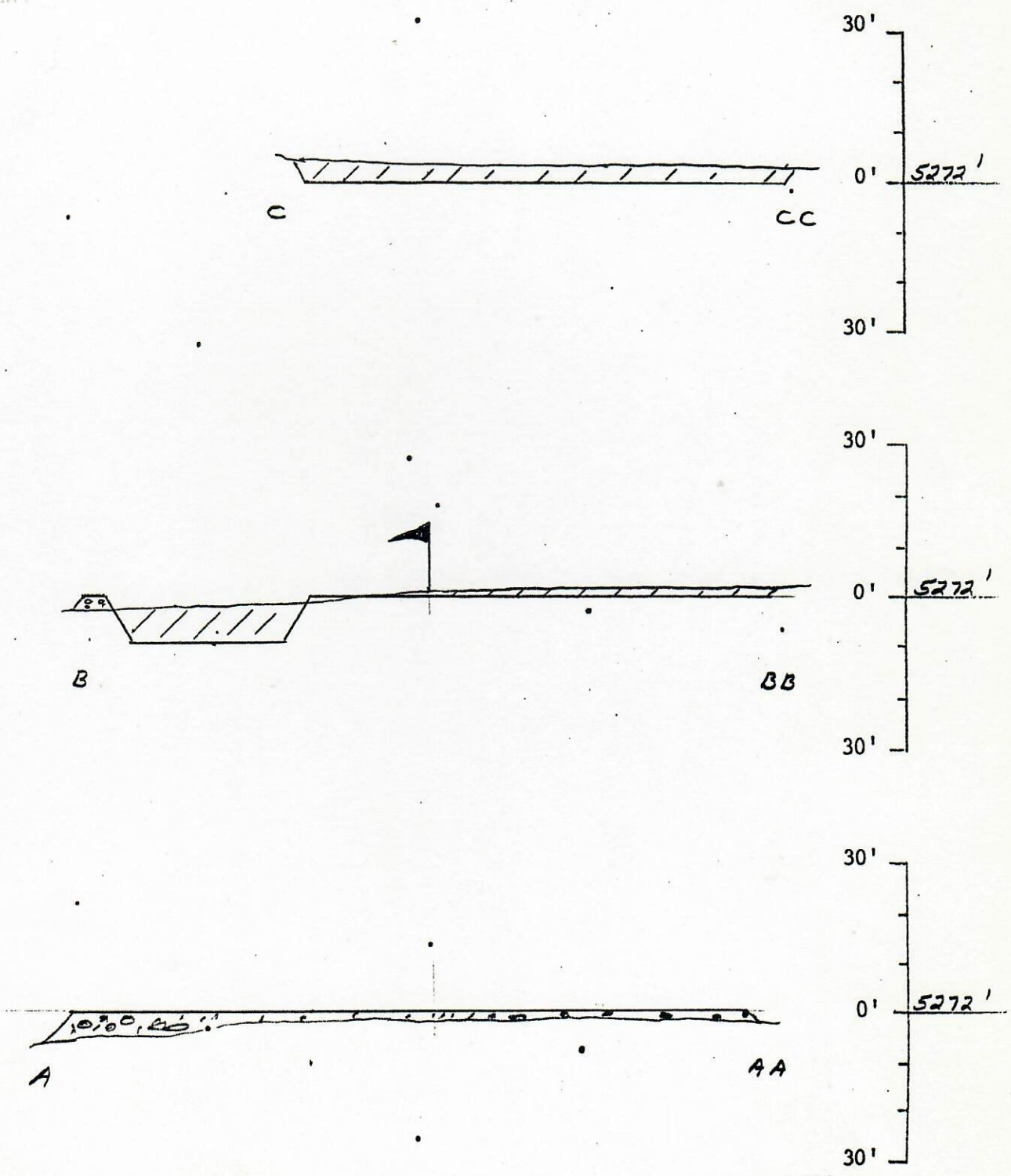


Diagram #2

WELL PAD PLAN VIEW

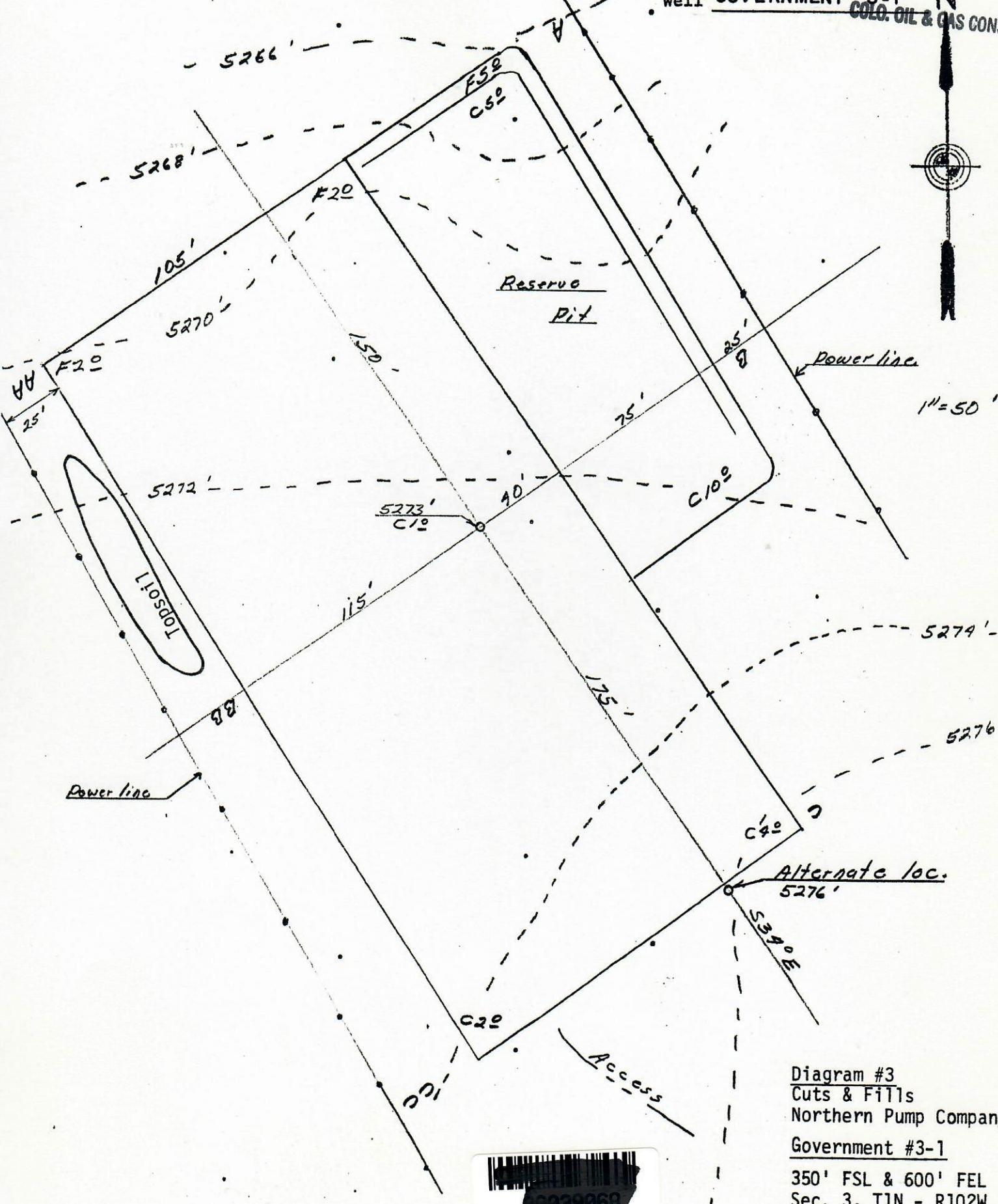
