INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the UPV 13-10I4 (FKA UPRC13-10I4) wellhead cut and cap and will be conducted pertaining to the flowline removal. Approximately 98' of flowline will be removed, however a portion of the flowline will be abandoned-in-place due to field constraints. The ECMC will be updated in a supplemental Form 27. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. So as to not disturb the area of field constraint, soil samples will be taken at the start and endpoint of the flowline where the area exists. Soil samples will also be taken along the flowline any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Visual inspection of the flowline areas will occur during abandonment activities. Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if additional laboratory confirmation sampling is required. The ECMC Flowline Closure and Wellhead Closure Checklists will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

Wellhead decommissioning activities and confirmation soil sampling at the UPV 13-1014 (FKA UPRC 13-1014) wellhead occurred on May 16, 2024. Two confirmation soil samples were collected from the wellhead excavation (WH01@6) from approximately 6 feet below ground surface (ft-bg) and from adjacent to the wellhead flowline riser (FLR01@4) from approximately 4 ft-bgs. One confirmation soil sample (FLR01@4) was collected from approximately 4 ft-bgs from adjacent to the wellhead flowline riser and reported 1,2,4-trimethylbenzene (4.53 mg/kg), 1,3,5-trimethylbenzene (3.61 mg/kg), naphthalene (0.243 mg/kg), gasoline range organics (GRO) (567 mg/kg), diesel range organics (DRO) (1,160 mg/kg), residual range organics (ORO) (536 mg/kg), total petroleum hydrocarbons (TPH) (2,263 mg/kg), 1-methylnaphthalene (1.03 mg/kg), and 2-methylnaphthalene (1.80 mg/kg) above the Table 915-1 ECMC GWSSLs and was reported as a historic release in Form 19 document number 403827247. Hydrocarbon impacted material at the wellhead will be removed and hauled to a permitted disposal facility. Final analytical results will be summarized in a subsequent Supplemental Form 27 submittal and will be reported along with ongoing Remediation Project Number 32589.

Based on the discovery of historic hydrocarbon impacts at the wellhead, source mass removal activities will be initiated following landowner negotiations. The implementation schedule has been updated to reflect these changes.

OPERATOR COMMENT

This Supplemental Form 27 was prepared at a timeline update for the historic release that was discovered at UPV 13-1014 (FKA UPRC 13-1014) wellhead and in connection with the initial Form 19 submitted under Document 403827247.

Following landowner negotiations, hydrocarbon impacted material at the wellhead will be removed and hauled to a permitted disposal facility and tentatively scheduled to be started at the site by the beginning of the fourth quarter of 2024. Flowline decommissioning activities have not yet commenced but will be summarized in a subsequent supplemental form 27 submittal.
