A site investigation was conducted pursuant to ECMC Rule 911 at the DILLER SCHAFER T3N-R65W-S13 L01 Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumphine(s) of any separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. Three background soil samples (BKG01) were collected from one location near the facility and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, and EC. Background soil samples were collected from depths ranging between 0.5 to 5 feet below ground surface (ft bgs). Arsenic was observed in three background soil samples above ECMC Table 915-1 standards.

A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the organic exceedance observed at sample locations PWV-01-B@5' and AST01@0-6" during decommissioning. A proposed SSI map is attached to this Form 27. Based on the naphthalene, TPH, arsenic, and pH exceedances identified during decommissioning, Noble proposes to limit future soil sampling to BTEX, naphthalene, 1,2,4,-TMB, 1,3,5-TMB, TPH (C6-C36), arsenic, and pH. Concurrently with the SSI, additional background samples will be collected to determine if arsenic and pH are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

If soil that is more heavily impacted with hydrocarbon compounds (based on PID readings, visual and/or olfactory indicators) is discovered during the SSI, a soil sample will be collected from that location and analyzed for full ECMC Table 915-1 contaminants of concern. If additional analytes are discovered from this new waste characterization sample in exceedance of ECMC Table 915-1 standards beyond those proposed in the above amended sampling plan request, those compounds will be added to the sampling plan.
