INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the BETHYL GW29-12 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the BETHYL GW29-12 flowline. Approximately 710' of flowline was abandoned in place. See ECMC Form 44 Doc # 403624203.

Five (5) grab soil samples were collected at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead.

Two (2) grab soil samples were collected at the flowline end points (at the wellhead and at the separator) during flowline abandonment activities.

Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, ECMC Table 915-1 metals, EC, SAR, pH, and boron. All site investigation samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Results of the excavation/confirmation sampling indicate that all current organic concentrations are in compliance with ECMC Table 915-1 regulatory limits. However, further evaluation of residual arsenic and barium appears warranted at this time.
