FINAL RECLAMATION PROCEDURE**



In September, 1999, Weber Water Service, Inc. (Sheridan Lake, CO) reclaimed the referenced location as follows:

1. Squeezed and pumped mud from reserve pit.
2. Cleaned and stockpiled trash off location.
3. Pushed materials back into pits.
4. Dressed up location and respread topsoil.
5. Reseeded location with landowner's specified seed mixture.
6. Hauled trash from location

NOTE: Reclamation was done as per landowner's direction, and location has been fully reclaimed to his satisfaction.
