<p>Following cut and cap operations at the Fehr 7, 24, 25-32 wellhead locations on September 11, 2024, soil samples were collected from the former wellheads and flowlines and submitted for laboratory analysis of the full ECMC Table 915-1 analytical suite using ECMC-approved methods appropriate for detecting the target analytes. Analytical results received on September 25, 2024, indicate that the barium concentration in soil samples WH-B01@6', WH-B01-01@6', FL-B01@4' and/or FL-B01-01@4' from the Fehr 7, 24, 25-32 associated wellheads exceeded the applicable ECMC Table 915-1 standard and background limits. Assessment activities are ongoing and will be summarized in a forthcoming Form 27-Supplemental Site Investigation and Remediation Workplan under Remediation Project No. 31098 (approved Form 27 Document No. 403816196). A topographic Site Location Map showing the geographic setting of the release is provided as Figure 1. The soil sample locations are illustrated on Figures 2 through 4. Soil sample location and field screening data are presented in Table 1. Soil analytical results are summarized in Table 2 through 5. The laboratory analytical reports are attached. Field notes and a photographic log are provided as Attachment A. The State Notification email is provided as Attachment B.</p>
