### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This oil and gas Location is in the Colorado Energy and Carbon Management Commission (ECMC) Orphaned Well Program (OWP). This initial Form 27 is submitted for site investigation activities performed during decommissioning of Oil and Gas Facilities, specifically sampling activities beneath production equipment including aboveground storage tanks (AST), produced water vaults (PWV), separators, on-location and off-location flowlines. At a minimum, soil samples will be submitted to an accredited environmental laboratory for analysis of Table 915-1 parameters from beneath each piece of equipment, at flowline risers and connection points, and from the base of the excavation. Soil samples will be collected and analyzed in accordance with Colorado ECMC 900 Series Rules.

Grab soil samples will be collected from areas most likely to exhibit E&P Waste impacts. Soil samples will be submitted for analysis of Table 915-1 parameters including organic compounds (TPH ranges C6-C36; BTEX; 1,2,4-Trimethylbenzene, 1,3,5-Trimethylbenzene, Naphthalene, PAH) and inorganic compounds [metals (As, Ba, Cd, Cu, Cr6+, Pb, Ni, Ag, Zn) and soil suitability for reclamation parameters (pH, EC, SAR, hot water soluble boron)].

The former BEHRENS RESOURCES INC - 10695 FARM RANCH EXPLORATION-62S64W/34SEW Production Facility (Location ID #475504) and the related FARM RANCH EXPLORATION #1 (OWP) (API #05-001-07466) and FARM RANCH EXPLORATION #2 (OWP) (API #05-001-07672) are in the ECMC Orphaned Well Program ("OWP"). The depth to groundwater is expected to lie at 100 feet or more bgs. This supplemental Form 27 presents the site investigation and remediation workplan for the FARM RANCH EXPLORATION-62S64W/34SEW Production Facility and related flowline decommissioning/removal. Soils beneath equipment including, but not limited to the aboveground storage tanks (AST), produced water vaults (PWV), separators and flowline risers and connection points will be assessed and field screened. Soil samples will be collected from areas where E&P Waste impacts are most likely to have occurred. Soil samples will be submitted to an accredited environmental laboratory for analysis of full Table 915-1 parameters. The OWP will submit a supplemental Form 27 within 90 days following results receipt.
