Laboratory analytical data indicated a historical release occurred at the wellhead flowline riser during the Timbro Federal LD18-74HN wellhead decommissioning. One soil sample, FLR01, exceeded ECMC standards for 1-methylnaphthalene at 0.020 mg/kg.
