<p>ECMC Inspection Report Summary</p> <p>WEATHER CONDITIONS: partly cloudy, dry ground</p> <p>On Friday, September 27, 2024 at approximately 815, I, Inspector Brittani Santistevan, conducted an on-site inspection at JOHN HORST B #1 (KP Kauffman Company, Inc), at location ID: 318553 in WELD COUNTY, Colorado.</p> <p>While there, I observed a shut-in facility.</p> <p>During this inspection the following possible compliance issues were observed:</p> <p>1. Well has been SI since 3-2021 & last produced 2/2021. Well is overdue for Mechanical Integrity Test. MIT requires 10-day notification via Form 42. Well plugging requires an approved Form 6 Intent to Abandon to Plug Well. Produce well after performing successful mechanical integrity test per Rule 417 or plug well. To maintain shut-in status, the well must be able to demonstrate ability to produce without mechanical intervention. (Corrective Action Date: April 26, 2024)</p> <p>2. It appears to be overgrown vegetation on various areas of location. Remove to comply with Rule 606.
