Reclamation of the CHEVRON SHALE 1-25A in accordance with Rule 1004.a will commence in the 2025 season. The pad will be recontoured to match pre-existing contours and topsoil will be redistributed after the pad is recontoured. After 1-25A is recontoured the pad will be seeded with the appropriate seed mix with soil supplements added to encourage quick plant growth. At the same time the well pad is reclaimed the road to the pad will be reclaimed, recontoured, and seeded with additional soil supplements. Rushing Vegetations Management was escorted to the 1-25A well on 7 August 2024 pad and all noxious weeds were sprayed with herbicide to rid the pad area of all noxious weeds. Mullen was evident as the above comment indicates and was sprayed with herbicide as noted in the following pictures. Pictures are attached.
