Minimum required soil analysis includes the following Table 915-1 Contaminants of Concern: TPH (C6-C36), benzene, toluene, ethylbenzene, total xylenes, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene and soil suitability for reclamation parameters: electrical conductivity (EC), Sodium Adsorption Ratio (SAR), pH, and boron.

If impacts are observed Operator shall analyze soil samples for complete Table 915-1 Contaminants of Concern.
