## **INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the GUTTERSEN USX D21-17 wellhead cut and cap and will be conducted pertaining to flowline removal. Approximately 1176' of flowline will be removed. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway.

## **PROPOSED SAMPLING PLAN**

### **Proposed Soil Sampling**

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

### **Proposed Groundwater Sampling**

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

The material excavated during the cut and cap operations was used as backfill for the excavations.

Site investigation dates have been updated based on the dates field activities were completed.

**OPERATOR COMMENT**

Facility closure activities and confirmation soil sampling were conducted at the Gutteresen USX D21-17 wellhead on August 13, 2024. Four discrete soil samples were collected from the sidewalls of the wellhead excavation in each cardinal direction from the wellhead and field screened using a photo-ionization detector (PID) calibrated with 100 parts per million (ppm) isobutylene gas. All soil samples screened with a PID at the wellhead resulted in readings equal to or less than 117.8 ppm.

A total of 2 facility closure confirmation soil samples were submitted for analysis. Soil Samples were collected from the floor of the wellhead excavation (WH01@6), and from the southern sidewall of the wellhead excavation (WH01-S@4). All soil samples were submitted to Origins Laboratory, Inc. in Denver, Colorado for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, gasoline range organics (GRO) [C6-C10] by EPA Method 8260D, diesel range organics (DRO) [C10-C28] and residual range organics (ORO) [C28-C40] by EPA Method 8015D, polycyclic aromatic hydrocarbons (PAHs) (Table 915-1 list) and naphthalene by EPA Method 8270E, Total Metals by EPA Method 6020B, Hexavalent Chromium by Total Metals by 7196A Method, electrical conductivity (EC) by Mod. Method 9050A, sodium adsorption ratio (SAR) by 20B Saturated Paste Method, and pH by 9045D Method, and boron by DTPA Sorbitol Method.

All analytical results for soil samples submitted for analysis are compliant with their respective Table 915-1 Protection of Groundwater Soil Screening Levels (GWSSLs), except for pH in soil samples WH01@6 (8.34) and WH01-S@4 (8.43), arsenic in soil samples WH01@6 (2.51 mg/kg) and WH01-S@4 (2.81 mg/kg), and barium in soil samples WH01@6 (253 mg/kg) and WH01-S@4 (96.1 mg/kg). All organics were reported as below their respective Table 915-1 GWSSLs. Groundwater was not encountered during wellhead cut and cap activities.

Noble is currently in the process of evaluating pH, arsenic, and barium concentrations at the wellhead. Pending location landowner approval and crew availability, Noble plans to conduct background soil sampling via hand auger from at least three boring locations at similar depths and soil horizons as confirmation soil samples, in areas away from oil and gas infrastructure. Flowline decommissioning activities will be summarized in a subsequent supplemental form 27 submittal.

Sample location information is provided in Table 1. Soil sample and field screening locations are presented on Figure 2, and analytical results are summarized in Table 2, Table 3, Table 4, and Table 5.
