INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared in accordance with ECOM Rule 911.a to provide prior notice of closure of the Swanson #1-A partially buried tank. Visual inspection and field screening of soils will be conducted following decommissioning of the associated infrastructure. Soil and groundwater (if present) samples will be collected and submitted for laboratory analysis to determine if concentrations and values are in compliance with ECOM Table 915-1. The topographic Site Location Map showing the geographic setting of the site as well as proposed soil sample map for the tank battery location are provided. Note: the tank battery is to be closed under the Swanson #1-A Location ID #307040. The Swanson #1-A Wellhead and On-location Flowline are not being decommissioned at this time.
