INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut and cap operations were completed at the Kirkmild 9-15A wellhead on July 17, 2024. Groundwater was not encountered in the wellhead cut and cap excavation. Visual inspection and field screening of soil around the wellhead and associated pumping equipment were conducted following cut and cap operations, and a soil sample (B01 @6') was submitted for analysis of full list ECMC Table 915-1 constituents, to determine if a release occurred. The flowline associated with the wellhead was removed between July 17 and July 25, 2024, and soil samples were collected from the locations where the flowline risers were disconnected from the wellhead (WH01-RISER@3') and from the separator (SEP01-RISER@4'). The samples were submitted for laboratory analysis of full list Table 915-1 constituents to determine if a release occurred. Laboratory analytical results indicated that soil samples were in compliance with the ECMC Table 915-1 standards or within site-specific background levels. The wellhead excavation and flowline are depicted on Figures 1 and 2. The PID readings and soil sample results are summarized in Tables 1 and 2, respectively. The Form 44 is attached.

On July 17 and July 19, 2024, soil samples were collected from the base of the cut and cap excavation (B01 @6') and from the locations where the flowline risers were disconnected from the wellhead (WH01-RISER@3') and from the separator (SEP01-RISER@4'). The samples were submitted for laboratory analysis of full list ECMC Table 915-1 constituents, using ECMC-approved methods. Laboratory analytical results indicated that soil samples were in compliance with the ECMC Table 915-1 standards or within site-specific background levels. The wellhead excavation and flowline are depicted on Figures 1 and 2. The laboratory reports are attached.

Between July 17 and July 25, 2024, visual inspection and field screening of soil were conducted at four sidewall locations within the cut and cap excavation area, four locations at the ground surface adjacent to the cut and cap excavation, and 14 flowline potholes. Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the screening locations, and no soil samples were submitted for laboratory analysis from these areas, in accordance with the ECMC Operator Guidance. A photo log is attached.

On July 24, 2024, a soil gas survey was conducted at four soil vapor points installed adjacent to the former wellhead location following cut and cap operations. A fifth point was blocked and could not be screened. GEM 5000 readings were non-detect for methane at all remaining points. The soil vapor point locations are depicted on Figure 1. The field form is attached.

Six background soil samples (NATIVE-BG01@3' through NATIVE-BG03@3' and NATIVE-BG01@6' through NATIVE-BG03@6') were collected from the native material outside of the cut and cap excavation. Ten additional background soil samples were collected during the Parker 16-15A wellhead decommissioning activities (Remediation No. 35020) located in the same quarter section and NRCS soil type. The background soil samples were submitted for laboratory analysis of pH, electrical conductivity (EC), sodium adsorption ratio (SAR), boron, and Table 915-1 metals, using ECMC-approved methods. Results indicate that pH, arsenic, barium, hexavalent chromium, and selenium are naturally high in the native soil. The background sample analytical results are summarized in Table 2. The background soil sample locations are depicted on Figure 3.

Laboratory analytical results indicate that full list Table 915-1 constituent concentrations in the soil samples collected from the cut and cap excavation (B01@6') and from the locations where the flowline risers were disconnected from the wellhead (WH01-RISER@3') and from the separator (SEP01-RISER@4'), were in compliance with the ECMC Table 915-1 standards or within site-specific background levels; therefore, no soil was removed from the site during wellhead cut and cap and flowline removal activities. The excavation area has been backfilled and contoured to match pre-existing site conditions.

REMEDIAL ACTION SUMMARY

Laboratory analytical results indicate that full list Table 915-1 constituent concentrations in the soil samples collected from the cut and cap excavation (B01@6') and from the locations where the flowline risers were disconnected from the wellhead (WH01-RISER@3') and from the separator (SEP01-RISER@4'), were in compliance with the ECMC Table 915-1 standards or within site-specific background levels. Groundwater was not encountered in the wellhead excavation or flowline potholes. Based on the analytical and soil screening data presented herein, assessment is complete at this site and no further activities are required. As such, KMOG is requesting a No Further Action (NFA) determination for this location.
