Morning Wes and Crew, (This might go to the ROW Crew out of GJ, please let me know if that is the case)

Notification for a release that occurred during a pressure test. The line had complete failure and there was some residual within that escaped. All fluid was either contained within the hole

or on the surface nearby. Estimate is close to +/-32bbbls lost with 30bbbls recovered right now (awaiting operations #'s and Tickets from water recovery efforts).

I want to get working on this quickly. Could you let me know if there is anything that would hold us up from the excavation/cleanup (i.e. Threatened and Endangered plants, etc).
