Operator has performed final reclamation activities, with the evidence of drill rows and straw crimped mulch.
 Tank battery and access road- was shared with another nearby well. Germination of plant species appeared to be restricted to areas where straw mulch was present. Bare area with no straw mulch had little to no germination.
 Well location- was predominately weedy, annual vegetation.

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1004.
