## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to provide prior notice of the plugging and abandonment of the HSR-Creason 11-5 and HSR-Bell 12-5 wellheads and the permanent removal of the associated flowlines. The off-location flowline system pre-removal notices were submitted under Form 44 Document No. 403916983 and 403916966. In accordance with ECMC Rule 911.a., soil and groundwater (if present) samples will be collected and submitted for laboratory analysis of the ECMC full Table 915-1 to determine if soils are in compliance. Visual inspection and field screening of soils around the wellheads and associated flowlines will be conducted during sampling activities. Soil vapor screening will also be performed around the wellheads. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

Following wellhead cut and cap operations, soil will be field screened at the wellheads, wellhead and separator risers, and associated flowlines. If impacted soils are encountered, a waste characterization soil sample will be collected from the areas exhibiting the highest degree of impact based on visual, olfactory, and/or field screening observations and analyzed for all analytes listed in ECMC Table 915-1. In the absence of apparent impacts, a soil sample will be collected from the base of the excavation adjacent to the wellheads, adjacent to the wellhead and separator risers, and areas most likely impacted during the operational life of the flowlines and analyzed for all analytes listed in ECMC Table 915-1. Soil samples will be submitted to an accredited laboratory for analysis using standard methods appropriate for detecting the target analytes in ECMC Table 915-1. Proposed soil sample and screening locations are provided on Figure 2 and 3.

### Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? ( Number, analyses, and locations of samples ):

If groundwater is encountered during plugging and abandonment activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for all analytes listed in ECMC Table 915-1 Organic Compounds in Groundwater (benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene (1,2,4 – TMB), and 1,3,5-trimethylbenzene (1,3,5 – TMB)) and Groundwater Inorganic Parameters (total dissolved solids (TDS), chloride, and sulfate) using standard methods appropriate for detecting the target analytes in ECMC Table 915-1.

## Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan ( summary ):

A waste characterization profile will be developed utilizing the initial sampling results analyzed for full Table 915-1. All detected organic compounds and metals, including boron, and all Soil Suitability for Reclamation analytes above Table 915-1 concentration limits in the initial sampling will be included in the established waste characterization profile and applied to excavation confirmation sampling. Once established, only analytes included in the waste characterization profile will be applied to additional required sampling. Following cut and cap operations, a soil vapor survey will be conducted adjacent to each of the former wellhead locations utilizing a maximum of five (5) soil vapor points for each wellhead. The proposed soil vapor point locations are illustrated on Figure 2.
