Laboratory analytical data indicated a historical release discovered beneath an aboveground storage tank during the Roach N-65N67W 14NWSE tank battery decommissioning. One soil sample, AST01, exceeded ECMC standards for 1-methylnaphthalene at 0.0194 mg/kg, and 2-methylnaphthalene at 0.0357 mg/kg. The supplemental Form 27 will be submitted for remediation number 36226 detailing the remedial site plan, document number 403916727.
