SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

Limited source removal occurred and approximately cubic yards have been removed and hauled for disposal. Confirmation soil samples were collected and submitted for ECMC Table 915 analysis. Analytical results indicate elevated levels of pH, SAR, DRO and ORO. Soil Sample points SS08, SS13, SS14, and SS19 were collected at the surface near the wellheads on top of a cement barrier. The elevated levels of pH are determined to be naturally occurring as a result of high alkalinity associated with cement products. Additional source removal will occur at SS08, SS13, SS14, and SS19 and confirmation soil samples will be collected for TPH (C6-C36), and SAR.

The Civitas Resources insurance program includes Excess Liability coverage of \$110,000,000 per occurrence and in the aggregate which sits over the sudden and accidental pollution within the General Liability coverage.
