This information was immediately relayed to the Production Field Supervisor, Chuck Smith. Production personnel were in close proximity to the pad at the time of the notification and responded to the potential leak within minutes. Upon investigation, it was discovered that a loose pump fitting was causing a slow drip of fluid (corrosion inhibitor) to run down the injection line and

over the lip of the containment structure. The fitting was immediately tightened and the leak was stopped. Fluids that collected in the containment structure were evacuated, and the small volume of stained soils off the NE corner of the containment were also cleaned up on the same day (10/14/24). M.
