Comment: There was no crop growth observed at the well site area approximately 60'x60'. This reclamation issue was also documented in the previous inspection. The surrounding undisturbed area is planted into winter wheat which is actively growing. There appears to be soil impacts from the wellsite which will require soil sampling, remediation, and reclamation. Any impacted soils should be removed and replaced with suitable topsoil for reclamation.
