Comment: There is an abandoned pipe riser/pig launcher approximately 250' south of the wellsite. There are areas at the former wellsite that have not established perennial vegetation and consists of weeds and bare soil. There may be impacted soils preventing vegetaion establishment. Soil sampling and anaylsis should be conducted to determine soil issues for reclamation. All reclamation needs to be completed before the next growing season.
