**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut and cap operations were completed at the Cogburn 4-29 wellhead on September 24, 2024. Groundwater was not encountered in the wellhead cut and cap excavation. Visual inspection and field screening of soil around the wellhead and associated pumping equipment were conducted following cut and cap operations, and a soil sample [B01(4-29)@6'] was submitted for analysis of full list ECMC Table 915-1 constituents, to determine if a release occurred. A portion of the flowline associated with the wellhead was removed on September 24, 2024, and a soil sample was collected from the location where the flowline riser was disconnected from the wellhead [WH01-RISER(4-29)@3']. The sample was submitted for laboratory analysis of full list Table 915-1 constituents to determine if a release occurred. Laboratory analytical results for both soil samples are pending. The wellhead excavation is depicted on Figure 1. The PID readings are summarized in Table 1. The Form 44 is attached.

Additional flowline removal activities are pending and will be summarized in a subsequent Form 27 Supplemental report.

On September 24, 2024, soil samples were collected from the base of the cut and cap excavation [B01(4-29)@6'], and from the location where the flowline riser was disconnected from the wellhead [WH01-RISER(4-29)@3']. The samples were submitted for laboratory analysis of full list ECMC Table 915-1 constituents, using ECMC-approved methods. Laboratory analytical results for all soil samples are pending. The wellhead excavation is depicted on Figure 1.

**Proposed Groundwater Sampling**

Will groundwater samples be collected as part of this investigation? ( Number, analyses, and locations of samples ):

Groundwater was not encountered during wellhead cut and cap operations.

If groundwater is encountered during flowline removal activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, using standard methods appropriate for detecting the target analytes in ECMC Table 915-1.

Additional alternative investigative actions described in attached Site Investigation Plan ( summary ):

On September 24, 2024, visual inspection and field screening of soil were conducted at four sidewall locations within the cut and cap excavation area and four locations at the ground surface adjacent to the cut and cap excavation. Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the screening locations, and no soil samples were submitted for laboratory analysis from these areas, in accordance with the ECMC Operator Guidance. A photo log is attached.

On October 2, 2024, a soil gas survey was conducted at two soil vapor points (SVPs) installed adjacent to the former wellhead following cut and cap activities. Three additional points were blocked and could not be screened. GEM 5000 readings were non-detect for methane at the remaining SVPs. The soil vapor field form is attached.

Twelve background soil samples (NATIVE-BG01@3' through NATIVE-BG06@3' and NATIVE-BG01@6' through NATIVE-BG06@6') were collected from native material adjacent to the wellhead cut and cap excavation. The background soil samples were submitted for laboratory analysis of pH, electrical conductivity (EC), sodium adsorption ratio (SAR), boron, and ECMC Table 915-1 metals, using ECMC-approved methods. Laboratory results are pending. Background sample locations are depicted on Figure 1.
