INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation will be conducted pursuant to ECMC Rule 911 at the WATSON T6N-R65W-S28 L02 Facility and Tank Battery location.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Grab confirmation soil samples will be collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), at the risers for the flowline (s) and dumpline(s) of any separator(s). In addition, the on-site dump lines located between the separator and tank battery will be removed by pulling from either end. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6 -C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Visual inspection at the tank battery area will occur during abandonment activities. Field personnel will field screen all disturbed areas using visual and olfactory senses. Additionally, discrete soil samples will be collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. The ECMC Tank Battery and Produced Water Vessel Closure Checklists will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

OPERATOR COMMENT

The Operator is submitting a Form 4 to assign a new location ID to the Watson E 28-17 and its production facility. Following approval of the Form 4 the Operator will amended Rem. # 38863 to include the facility decommissioning the was completed at the Watson E 28-17 facility (currently named Watson E 28-19). The Maps and data attached, plus the correct lat/long supplied with this Supplemental Form 27 correctly indicate samples were collected near the Watson E28-17 well.

The confirmation soil samples collected during the Watson E 28-17 (currently named Watson E 28-19) facility decommissioning activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling will be conducted via hand auger and grab confirmation soil samples will be collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), at the risers for the flowline(s) and dumpline(s) of any separator(s). Background samples will also be collected during this resampling event. These resampling activities will take place at and adjacent to the "corrected coordinates" provided in the Site Information section on this form.

The Operator recognizes that though the decommissioning lab results are invalid due improper preservation, impacts may be present at the Watson E28-17 facility. A soil sample collected beneath the former AST (AST01-B 0.5FT) was reported with an elevated concentration of Naphthalene. The exceeding soil sample location will be resampled and analyzed for the full Table 915-1 suite to confirm the original results. The Operator is proposing continue remediation and reporting under Rem. 38863 and close out the F19 Spill #488077. Pursuant to ECMC Rule 912.b the Operator will submit F19s as applicable for any and all impacted locations that are discovered following resampling activities at the Watson E 28-17 (currently named Watson E 28-19) facility.
