INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the JOHNSON G13-27D wellhead cut and cap and flowline abandonment. The wellhead was cut and capped per ECMC rules. Approximately 1545' of flowline was abandoned in place due to field constraints and the ECMC was notified on Form 44 Document Number 403266565.

Two (2) grab soil samples were collected at the wellhead excavation (1) and flowline terminus at the separator (1). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
