This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, or Wildlife Management area.

During the inspection, the following compliance issues were observed:

1. Housekeeping - Multiple loose barbed wire on location/wildlife hazard with a CA date of 11/03/2024
2. Housekeeping - Multiple debris on location with a CA date of 11/03/2024
3. Equipment - Open ended load lines with a CA date of 11/03/2024
