INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the WILMOTH 14-0314 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. Approximately 505' of flowline was removed; however, a portion was abandoned in place. The ECMC will be updated on a Supplemental Form 27.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Four (4) grab soil samples were collected at the wellhead excavation (1), flowline terminus at the separator (1), directional change (1), and cut-point of abandonment (1). Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Residual arsenic and barium at the former wellhead appears less than and/or consistent with background comparison and does not appear to warrant additional sampling.

A second background sample was collected from similar lithographic soil near the flowline path for EC, SAR, pH, boron, and ECMC Table 915-1 metals analysis. Flowline analytical data receipt pending.

OPERATOR COMMENT

The previous Form 27, 403737353, was approved and returned with the following COAs:

- 1) Operator has failed to adhere to the quarterly reporting schedule. Verbiage in this form implies that the flowline had been decommissioned at the time of this form submittal, 4/1/24, at the time of this review, 9/25/24, no flowline data has been submitted, 177 days. Operator shall submit all available data as soon as practicable.
- 2) All soils do not meet Table 915-1 standards. Multiple soil samples exceeded Table 915-1 standards for pH and one exceeded for SAR. These values are not representative of native soils based on comparison to the background data provided.

Noble intends to provide the flowline data, if received, next submittal. Noble intends to conduct additional delineation and background sampling within the next 6 months, weather and site access permitting.

Required quarterly reporting will be completed until site closure is approved.
