INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut and cap operations were completed at the Boyle St 8-16 wellhead on July 10, 2024. Visual inspection and field screening of soils around the wellhead and associated pumping equipment was conducted following cut and cap operations, and a soil sample (B01@6') was submitted for analysis of full list ECMC Table 915-1 constituents, to determine if a release occurred. Portions of the flowline associated with the wellhead was removed between July 8 and July 15, 2024. Groundwater was encountered in the combined separator excavation and at a flowline pothole location, at approximately 4 ft bgs. Soil samples were collected from the location where the flowline risers were disconnected from the wellhead (WH01-RISER@3') and from the separator (SEP01-RISER@4'), and from where groundwater was present (FL01@4'). The samples were submitted for laboratory analysis of full list Table 915-1 constituents to determine if a release occurred. Initial laboratory analytical results indicated that polycyclic aromatic hydrocarbon (PAH), pH, sodium adsorption ratio (SAR), and selenium impacts exceeding the ECMC Table 915-1 allowable levels or background levels were present at the base of the cut and cap excavation. A verification sample was collected and confirmed the PAH, pH, and SAR impacts. As such, a Form 19 Initial/Supplemental Spill/Release Report (Document No. 403880796) was submitted to the ECMC on August 9, 2024, and the ECMC issued Spill/Release Point ID 487611. The wellhead excavation and flowline are depicted on Figures 1 and 2. The PID readings and soil analytical results are summarized in Tables 1 and 2. The Form 44 is attached.

Additional flowline removal activities are pending and will be summarized in a subsequent Form 27 Supplemental report.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Between July 10 and September 12, 2024, excavation activities were conducted to address the soil impacts at the cut and cap excavation. Confirmation soil samples were collected from the base and sidewalls of the excavation at approximately 9 ft and 5 ft bgs, respectively. The samples were submitted for laboratory analysis of the site-specific waste profile including PAHs, boron, pH, SAR, and select Table 915-1 metals, using ECMC-approved methods. Laboratory analytical results are pending. The wellhead excavation and flowline are depicted on Figures 1 and 2. The laboratory reports are attached.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

On July 15, 2024, one groundwater sample was collected from a flowline pothole location (GW-FL01@4'). Groundwater at GW-FL01@4' was not in contact with impacted soil. Sample GW-FL01@4' was submitted for laboratory analysis of Table 915-1 organic constituents. Laboratory analytical results indicate that groundwater is in compliance with Table 915-1 allowable levels and all organic constituents were below the laboratory reporting limits. The separator riser excavation was combined with the facility separator excavation, and the groundwater sample collected in that location is being reported as part of Remediation No. 35212. The flowline pothole groundwater sample location is depicted on Figure 2. The groundwater sample analytical results are summarized on Table 3.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

On July 10 and July 15, 2024, visual inspection and field screening of soils were conducted at four sidewall locations within the cut and cap excavation area, four locations at the ground surface adjacent to the cut and cap excavation, and ten pothole locations. Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the screening locations, and no soil samples were submitted for laboratory analysis from these areas, in accordance with the ECMC Operator Guidance. A photo log is attached.

On July 25, 2024, a soil gas survey was conducted at five soil vapor points installed adjacent to the former wellhead location following cut and cap operations. GEM 5000 field readings were all non-detect for methane at all soil vapor points. The soil vapor point locations are illustrated on Figure 1. The soil vapor field form is included as an attachment.

Twelve background soil samples (NATIVE-BG01@3' through NATIVE-BG06@3' and NATIVE-BG01@6' through NATIVE-BG06@6') were collected from native material adjacent to the wellhead cut and cap excavation. The background soil samples were submitted for laboratory analysis of pH, electrical conductivity (EC), SAR, boron, and ECMC Table 915-1 metals, using ECMC-approved methods. Laboratory analytical results indicate that levels of EC, SAR, pH, boron, arsenic, barium, cadmium, hexavalent chromium, lead, nickel, and selenium are naturally high in the native soil. Background soil sample analytical results are summarized in Table 2. Background sample locations are depicted on Figure 1.

Impacted soil from the wellhead cut and cap excavation will be removed and transported to a licensed disposal facility. Additional flowline removal activities are pending and will be summarized in a subsequent Form 27 Supplemental report.
