INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation will be conducted pursuant to COGCC rule 911 at the ARISTOCRAT-63N65W 10NWNE (311345) oil and gas location pertaining to the cut/cap of the ARISTOCRAT 31-10C (05-123-12805) and abandonment of associated on-location wellhead line. All other wells and equipment will remain active. See site map exhibit for details.

Seven confirmation soil samples were collected for analysis by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Additionally, six of the samples were also analyzed for Table 915-1 metals.

If groundwater is encountered, a sample will be collected from the base of the excavation for laboratory analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, chlorides, sulfates, and TDS.
