### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A leak occurred in a 2 ½ inch fiberglass flow line at Fee 145. The cause of the leak was a worn spot on the flow line. Approximately 45.4bBbls of brine water and 0.337 bbls oil was released. All of the fluids were contained in the RWSU field.

The well was immediately shut in upon detection. Vacuum trucks removed all of the free fluid, estimated recovery is approximately 45.036 bbls of water and 0.337 bbls of oil. The fluids were picked up by vacuum truck and recycled at the truck unloading facility at the Main Water Plant.
