Laboratory analytical data indicated a historical release was discovered at the Shable USX AB11-03 decommissioned wellhead. One soil sample, WH01-N, exceeded ECMC standards for TPH at 3,057.2 mg/kg, 1-methylnaphthalene at 0.133 mg/kg, and 2-methylnaphthalene at 0.068 mg/kg. This location lies within the Pronghorn Winter Concentration Area high priority habitat.

Historical impacts were discovered during wellhead decommissioning activities at the north sidewall of the wellhead excavation. Due to the historical nature of the release, an exact cause was not able to be identified.

Describe measures taken to prevent the problem(s) from reoccurring:

Noble conducts routine AVO inspections of all oil and gas wellheads in order to identify and mitigate potential releases. Further, this wellhead is no longer active and is in the process of being decommissioned. The wellhead has been taken out of service, and there is no longer a possibility of a release originating from this infrastructure.

OPERATOR COMMENTS:

A historical release was discovered on 9/13/2024 during decommissioning activities; however, the consultant didn't comply with submitting the samples for same-day turn around and Chevron wasn't notified of the olfactory and visual observations. Chevron was notified by the consultant of the release on 11/1/2024. As a result, 24-hour notifications were not made, and a Form 19 was not submitted within 72 hours of the release discovery. In order to prevent this issue from reoccurring, chevron has required the consultant to notify about any site with any field indicators of a historical release as soon as it is observed during the decommissioning sampling. Chevron is committed to abiding to ECMC reporting standards and will make all necessary efforts to ensure this issue does not reoccur in the future.
