This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, or Wildlife Management area.

During the inspection, the following compliance issues were observed:

1. Equipment - Open ended load line with a CA date of 11/10/2024
2. Stormwater - Tunnel erosion in ditch, is also a wildlife/personal safety hazard with a CA date of 11/18/2024

A follow-up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
