INITIAL ACTION SUMMARY

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the DILLARD USX AB29-17 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. The flowline was previously abandoned on 12/06/2018, and the ECMC was notified on Form 44 Document Number 403216829.

One (1) grab confirmation soil sample was collected at the wellhead excavation, and soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

A background sample was collected from similar lithographic soil near the wellhead for EC, SAR, pH, boron, and ECMC Table 915-1 metals analysis. In the absence of organic, inorganic, and other metal concentrations exceeding ECMC regulatory limits, the residual arsenic concentration is not indicative of an E&P release and is consistent with current background comparison.
