INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the HSR-CUTLER 14-31 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. Approximately 890' of flowline was removed.

PROPOSED SAMPLING PLAN**Proposed Soil Sampling**☒ Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Seven (7) grab soil samples were collected at the wellhead excavation (5), flowline directional change (1), and flowline terminus at the separator (1). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. One (1) waste characterization sample was analyzed for ECMC Table 915-1 metals. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

A background sample was collected near the wellhead for pH and ECMC Table 915-1 metals (sans Cr VI) analysis. Additional backgrounds (5+) will be collected from soil of native/similar lithologic material not impacted by oil and gas activity to further arsenic and pH, as needed.

A site assessment will be scheduled to delineate residual petroleum hydrocarbon impacts at the former wellhead. Noble proposes soil samples be collected for analysis TPH (C6-C36), ECMC Table 915-1 organics, arsenic, and pH. If groundwater is encountered, each soil boring will be completed as a monitoring well and the groundwater will be sampled for BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, and inorganic parameters per ECMC Table 915-1.

No current source was generated. Residual petroleum hydrocarbon impacts will be delineated through an environmental site assessment. Noble proposes an amended Table 915-1 analytical plan to include TPH (C6-C36), ECMC Table 915-1 organics, arsenic, and pH. Additional backgrounds (5+) will be collected from soil of native/similar lithologic material not impacted by oil and gas activity to further arsenic and pH, as needed.

REMEDICATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Site assessment activities to delineate residual petroleum hydrocarbon impacts at the site are tentatively scheduled to be started at the site by the fourth quarter of 2024, pending landowner consultation. Remediation will be proposed in a supplemental 27 if applicable. NFA will be considered when soil and/or groundwater (if encountered) concentrations are in compliance with ECMC Table 915-1 standards.
