Comment: There are areas along the former access road that have not established perennial vegetation and soils appear to be compacted along these areas of the road. The location has been recontoured and reclaimed. The perennial vegetation appears to have re-established throughout the location. There is a fence that remains around the location which is not maintained and will need to be removed prior to final inspection. Overall, reclamation appears to be progressing however additional maintenance is required.
