A site investigation was conducted pursuant to ECMC Rule 911 at the WATKINS SATER T4N-R63W-S18 L01 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumpline(s) of any separator(s). Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the pH exceedances observed at sample locations AST02@0.5', FS01@4', SEP02-DL@3' and SEP02-FL@3' during decommissioning. A proposed SSI map is attached to this Form 27. Based on the pH and arsenic exceedances identified during decommissioning, Noble proposes to limit future soil sampling to pH and arsenic. Concurrently with the SSI, additional background samples will be collected to determine if pH and arsenic are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

The implementation schedule has been changed due to the decommissioning of the Sater CC18-18 tank battery and necessity for supplemental site investigation activities adjacent to the tank battery. The proposed site investigation will be completed following the approval of this form, landowner negotiations, and crew availability.

OPERATOR COMMENT

This Form 27 is being submitted to include the decommissioning results at the former Sater CC18-18 Tank Battery location. A proposal to delineate the pH exceedances identified during decommissioning (soil samples AAST02@0.5', FS01@4', SEP02-DL@3' and SEP02-FL@3') is presented in the Site Investigation Report section of this Form 27.

Based on the contaminants of concern identified during decommissioning, Noble proposes to limit future soil sampling to pH and arsenic. Concurrent with delineation activities, additional background samples will be collected to determine if pH and arsenic observed at this location are indicative of native material conditions.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
