Good Afternoon,

We identified a state reportable release due to over 1 barrel of produced fluids released outside secondary containment. The source of spill was isolated by onsite personal. Clean-up activities are currently in process. This release did not threaten Waters of the State, Public Water System, residences or occupied structures, livestock, wildlife, air quality, or publicly-maintained roads.

The following have been notified via specified method below:

- Weld County contacted via electronic mail
- Surface Owner notification in process
- The Public Water Supply Administrator of Hudson via electronic mail (GUDI & Type III Wells - Generalized External Buffer)

The Environmental Release/Incident Report Hotline and Colorado Parks and Wildlife were not contacted as this release did not trigger notification requirements per 912.b.(2)B.
