## OTHER INVESTIGATION INFORMATION

Were background samples collected as part of this site investigation?

Four background soil samples were collected from one discrete location (BKG01) at the nearby Village 42-16U Flowline, Remediation No. 35278. Additionally, four background samples were collected from two discrete locations (BKG01, BKG02) at the nearby Village 31-16DU and 41-16DU Flowlines, Remediation No. 31056. The background soil samples were collected from depths ranging from 3 to 6 feet below ground surface (ft. bgs), and analyzed for metals in soil per ECMC Table 915-1 and pH, the Village 42-16 flowline samples were submitted for additional analysis of EC, SAR, and boron. The highest background concentration for pH was observed to be 9.08, and the highest background concentrations for arsenic and barium with a 1.25x multiplier were calculated to be 7.24 mg/kg and 346 mg/kg respectively. All arsenic, barium and pH concentrations observed during decommissioning were below background levels.
