**General Comment:**

On October 29, 2024, ECMC Environmental Staff Krystal Heibel, Dylan Edwardson, Alex Fischer and Kyle Waggoner conducted an environmental field inspection of Western Operating Company (Western) Probst B #2 (Location ID: 312292).

During the time of the inspection, Ryan Finley (Entrada), Nick Yourd (Entrada), Ted Propst (surface owner), and Todd Troutman (DC Dozer Service) were on location.

This location has an associated AOC with Order No. (1V-870). Weather was cloudy and windy. For the most recent field inspection report of this facility, please refer to Document #709100421.

The following is a summary: Pit Facility ID 100311 is not in use and the Propst 2 well (API 075-09212) was active. The pit's berms were pushed into a stockpile south of the location and excavation to the west of the pit resulted in an additional stockpile on location. It appears that the excavation has increased the footprint of the oil and gas facility's location.
