Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

On 11/6/2024, the potential presence of impacted materials was identified via hydrocarbon odor and hydrocarbon staining, for PWV02-B. Partial laboratory analytical data indicated a historical release was discovered beneath the produced water vessel during Fritzler 17-23-18 tank battery decommissioning. One soil sample, PWV02-B, exceeded ECMC standards for benzene at 0.45 mg/kg, ethylbenzene at 2.3 mg/kg, 1,2,4-trimethylbenzene at 13 mg/kg, 1,3,5-trimethylbenzene at 4.7 mg/kg, naphthalene at 1.4 mg/kg, and TPH at 1820 mg/kg.

PDC conducts routine AVO inspections of all oil and gas facilities in order to identify and mitigate potential releases. Further, this facility is no longer active and is in the process of being decommissioned.
