A site investigation was conducted pursuant to ECMC Rule 911 at the REEVE T4N-R65W-S15 L01 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel excavation, beneath the ground oil tank, and at the risers for the flowline and dumpline of the separator. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic compounds per ECMC Table 915-1 and inorganic parameters (TDS, chloride, sulfate, sodium, potassium, bicarbonate, and carbonate (as CaCO₃)).

Visual inspection at the tank battery area occurred during abandonment activities. A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the pH exceedances observed during decommissioning at sample locations AST01@0.5', FS01@4', SEP01-DL@3', SEP01-FL@3', and SS03@2.5'. A proposed SSI map is attached to this Form 27. Based on the pH, arsenic, barium and selenium exceedances identified during decommissioning, Noble proposes to limit future soil sampling to the pH, arsenic, barium and selenium. Concurrently with the SSI, additional background samples will be collected to determine if the pH, arsenic, barium and selenium are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

Basis for change in implementation schedule:

The implementation schedule has been changed due to the decommissioning of the Reeve 41-15 1 tank battery and necessity for supplemental site investigation activities adjacent to the tank battery. The proposed site investigation will be completed following the approval of this form, landowner negotiations, and crew availability.

OPERATOR COMMENT

This Form 27 is being submitted to include the decommissioning results at the former Reeve 41-15 1 Tank Battery location. A proposal to delineate the pH exceedances identified during decommissioning (soil samples AST01@0.5', FS01@4', SEP01-DL@3', SEP01-FL@3', and SS03@2.5') is presented in the Site Investigation Report section of this Form 27.

Based on the contaminants of concern identified during decommissioning, Noble proposes to limit future soil sampling to pH, arsenic, barium and selenium. Concurrent with delineation activities, additional background samples will be collected to determine if pH, arsenic, barium and selenium observed at this location are indicative of native material conditions.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
