INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Site investigations took place on 1/26/24, 2/1/24, 9/6/2024 and 10/2/2024. 9/6/2024 and 10/2/2024 PID Field Screening and analytical results reveal TPH, pH, SAR impacts remain at the wellhead and FL endpoint separator excavation areas. Further excavation and confirmation samples are required at the WH and FL endpoint. Magpie Operating, Inc was approved for a reduced analytical suite of TPH (C6-C36), pH, SAR, Boron and Arsenic only in Doc No. 403695876. Operator requests a reduced analytical suite of TPH (C6-C36), pH, SAR and Boron. CPW requests that activities do not occur between Dec1-July 31 for Eagle nesting season.

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Impacts remain at the wellhead and separator excavation areas. Excavation and additional sampling is required. Samples will be analyzed for TPH (C6-C36), pH, SAR and Boron. CPW requests that activities do not occur between Dec1-July 31 for Eagle nesting season.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during facility decommissioning activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene, using standard methods appropriate for detecting the target analytes in ECMC Table 915-1.
